ⁱ Opens space types

- i. parks and gardens
- ii. natural and semi-natural urban greenspaces
- iii. green corridors
- iv. outdoor sports facilities (no or limited public access)
- v. amenity greenspace (most commonly, but not exclusively in housing areas)
- vi. play and activity space for children and teenagers
- vii. allotments, community gardens, and city (urban) farms;
- viii. cemeteries
- ix. accessible countryside in urban fringe areas; and
- x. civic spaces

ⁱⁱ Scale types

Town & parish significant sites (Local) such as large formal parks and destination play areas have strategic importance within the towns and contain sufficient facility to potentially attract visitors from outside the immediate community.

Neighbourhood 1 (small) sites have local importance and contain sufficient provision to meet the needs of the local community

Neighbourhood 2 (pocket size) sites are the least equipped or most basic amenity, and merely serve residents from the immediate area.

ⁱⁱⁱ Assessment scoring

Where a question is not relevant, it should be omitted so as not to skew the results; for example, the question about buildings may be irrelevant to a wild open space.
